The organization served 56 survivors, primarily in Nebraska, with additional services delivered across the United States and internationally through secure virtual platforms. Program services included individualized case management, one-on-one mentorship, and weekly support groups, including specialized groups for survivors of complex trauma. Structured programming focused on life skills, financial literacy, employment readiness, and identity development. The organization distributed approximately 2,492 in direct financial assistance through its Stability Grant program to support urgent needs such as housing, transportation, and food. Additional in-kind support, including clothing and essential household items, was provided. Innocence Freed assisted survivors with housing placement and referrals to residential recovery programs and provided advocacy support.
